## Patricia Hitchcock KC

### Overview

Patricia is a lawyer and trained as a mediator with the Centre for Dispute Resolution (CEDR) in 2003. She qualified as a barrister in 1988 and retired from the Bar in September 2021 to focus on judicial and mediation work. She has particular expertise in clinical negligence, mental health and catastrophic injury cases. She is a member of the CEDR and NHR Panels and is registered with the Civil Mediation Council. She remains an Associate of her chambers, Cloisters, and accepts instructions both through CEDR and through Cloisters. Patricia was appointed a Recorder in 2017.

### Background

- After reading English at Oxford, Patricia worked as a non-fiction book editor for nine years before being called to the Bar in November 1988. The change of career followed her election to lead the NUJ chapter at Hutchinson Books during a company takeover, discovering an aptitude for advocacy. She trained at City University, ICCL, Devereux Chambers and then at Cloisters, where she was taken on as a tenant in 1990.
- Her wide-ranging common law practice initially encompassed employment, discrimination, housing, personal injury and criminal injuries compensation, with a primary focus on criminal defence work, appearing in over 100 criminal trials, often at the Central Criminal Court, and in the Court of Appeal.

- At less than ten years' call she moved into civil litigation, specialising in life-changing personal injury and clinical negligence cases. She also represented many high-profile applicants for state compensation for unjust imprisonment.
- She was appointed Queen's Counsel in 2011 and to the judiciary as a Recorder in 2017.
- She continues to sit part-time as a Recorder in the Crown Court, hearing serious criminal cases, and in the First Tier (HSEC) Tribunal on the Restricted Patients Panel.
- Patricia was an early adopter of mediation, qualifying with CEDR in 2003, and has maintained an interest in mediation throughout her career. She has often appeared as an advocate at mediations, as well as assistant and then lead mediator. She is a member of the CEDR and NHSR Panels and is registered with the CMC.

Her practice brought her into contact with a wide range of individuals with varied communication needs, from senior judges and silks to clients who were often young and/or cognitively damaged, and their families.
