Dispute Experience

Commercial Contracts

Andy has dealt with numerous contract disputes involving goods, professional services, and leases, dealing with issues ranging from renewals and extension negotiations, terminations, misrepresentation and fulfilment of contract. Many of his cases have been cross-border contracts. Claim values range from £50,000 to £5 million. Due to Andy's background in the area of consultancy and agency he has dealt with a variety of multinationals and boutique services. With his background in technology, telecoms and travel sectors, in addition to working with Venture Capitalists, these issues have featured in the disputes Andy has mediated. One example was an agency agreement relating to wardrobe for one of the world's most famous international recording artists.

Property

Andy has mediated claims in both commercial and residential property disputes, ranging in value from to £10,000 to £30 million. Parties have ranged from major corporations working in Energy, Retail, Leisure, through to large-scale international investors, as well as Educational Institutions and private and public landlords and tenants. Many of the disputes Andy has successfully mediated share a feature of having been ongoing for over 5 or 10 years.

Construction & Engineering

Andy has dealt with a wide ranging of construction and engineering disputes, many of which involved project additions, annexes, extensions or redevelopments. A number of the disputes mediated by Andy include University Campuses, Schools and other educational establishments, in addition to commercial and residential buildings. Claim values range from £40,000 to £10 million.

- Construction, contractor and subcontractor disputes.
- Schedule of works frequently feature in his mediations.
- Construction sub-contractor disputes.
- Redevelopment of residential and commercial sites.
- Land use, suitability for building and tree roots.

Trust, Wills & Probate

Over the course of Andy's mediation practice these disputes have made-up a considerable proportion of his work. Clients have particularly valued his ability to work well with older parties in helping them find an amicable solution. He has dealt with a number of disputes for the families of academics, doctors and politicians. Claim values range from £40,000 to £3 million.

Employment & Workplace
